**2.1.1 Keyboard**

MMAD supports standard keyboard navigation and input functions (such as pressing [Tab] to move between input fields), however some areas still require the use of a pointing device. Specifically the Migration to O365 (DMA) console has controls with no keyboard option.

**2.1.2 No Keyboard Trap**

If keyboard focus can be moved to a component of the page using a keyboard interface, then focus can be moved away from that component using only a keyboard interface, and, if it requires more than unmodified arrow or tab keys or other standard exit methods, the user is advised of the method for moving focus away.

**2.1.4 Character Key Shortcuts**

If a keyboard shortcut is implemented in content using only letter (including upper- and lower-case letters), punctuation, number, or symbol characters, then either the keyboard shortcut is only active when that component has focus or a mechanism is available to turn the shortcut off or to remap the shortcut to use one or more non-

### **2.2.1 Timing Adjustable**

MMAD user interface uses a mostly logical tab order through most of the interactive elements such as links and form controls, although some areas require the use of a pointing device. (tabs in Synchronization properties for example, DMA Console controls)

**2.4.4 Link Purpose (In Context)**

The purpose of each link can be determined from the link text alone or from the link text together with its programmatically determined link context, except where the purpose of the link would be ambiguous to users in general.

**2.5.1 Pointer Gestures (2.1 only)**

All functionality that uses multipoint or path-based gestures for operation can be operated with a single pointer without a path-based gesture, unless a multipoint or path-based gesture is essential.

**2.5.2 Pointer Cancellation (2.1 only)**
